### WHAT YOU NEED FOR THE CONTEST

All contestant applications must include **2 digital pictures** (jpeg format) of their face (un-hooded) and body in LEATHER gear

All candidates must prepare and bring on the night of the contest at least **3 wardrobes**, including the one used for the performance

Performances must respect the rules and regulations of the contest venue.

Bad behaviour, nudity or sexual acts will not be tolerated and may result in the candidate's disqualification.

### SELECTION CRITERIA

**Candidates will be selected for the contest based on the quality of their responses to the application questions.**

They will also be judged at the contest according to their appearance, charisma and interest/passion for Leather.

**During the contest, contestants will be judged on the following criteria:**

(1) the quality of their responses to the application questions; (2) charisma; (3) stage presence; (4) appearance in gear; (5) originality & artistic vision of the performance piece; (6) verbal eloquence, (7) ease on stage.

### CONTRACTUAL OBLIGATIONS
